Thank you for choosing Southern Ohio Association of REALTORS®, Inc. as your local Association. The following agreement spells out the terms and conditions of an optional payment plan. If you elect to participate in a payment plan for your 2011 local dues renewal and/or your 2012 State and National dues renewal, please keep a copy for your records and return a signed copy by **February 10, 2011**.

Any member who opts to participate in the payment plan must put a credit or debit card on file or submit bank routing numbers for automatic payment processing in installment payments as shown in the schedule below. Important Notice: Your Broker is also required to sign the agreement.

Payments will be made on the dates stated below. Payments will be made by the following two methods: (1.) automatic draft by Park National Bank to your checking or savings account ; (2.) automatic charge to your designated credit or debit card.

Upon signing this agreement you agree to pay the 2011 Local Dues and 2012 State and National Dues in 10 installments of \$39.00, with an authorized charge on the credit card listed below. Insufficient funds will incur a \$10.00 fee. **A \$36 convenience fee will be charged for processing the payment plan option for Local dues plus State and National Dues. A \$27 convenience fee will be charged for Local dues only.**
